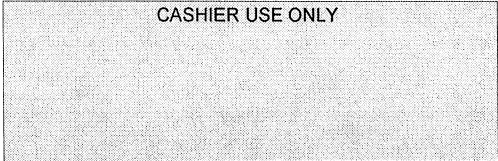

(RCW 15.60.021)
